Final Notice

It is notified for the information of the general public and stakeholders (Publishers/Book Sellers) that the college has published tender notice, dated 16/06/2022 for purchase of books /references etc. for College Library under the terms and conditions specified.

After the date of tender receipt was over, the college received twenty one tenders from the firms. Subsequently a meeting of the College Library Committee was held on 25/06/2022 in which all the parties were present in the meeting. All the firm holders /booksellers, who had submitted tenders unanimously, submitted an undertaking individually expressed the interest to give discount at 22% on paperback and 26.5% on hardbound books. However some of the firm holders had submitted cheques instead of CDR's which were recommended by the committee for consideration as there was a technical glitch with the J&K Bank Website server due to which they could not submit the CDR's in due course of time.

After discussing the matter at length, the committee therefore, expressed interest in publishing a notice through the College Website dated 22/07/2022 for seeking grievances /objections with regard to the empanelment process and subsequently received seven grievances from the suppliers /firms.

After analyzing the grievances submitted by the firms referred at annexure "A" a meeting of the College Library Committee and IOAC was held on 25/07/2022 at 3.30 pm. The committee sought legal advice about the matter also and after discussion about the developments recommended that due to the technical problem of the J&K bank Website, the rights of the firms /suppliers cannot be snatched and therefore expressed interest in providing an opportunity to the suppliers who had submitted cheques instead of CDRs.

Consequently, final notice with reference to the MOM dated 25/07/2022 is given to the following suppliers/publishers for submitting CDR's in original by or before 27th of July 2022 failing which the candidature of their firms /suppliers shall be considered to have been cancelled and no any further extension whatsoever shall be considered.
